Short Title: Taxpayer Transparency Act. (Public) Representatives Blust, Blackwell, and Saine (Primary Sponsors). Sponsors: Referred to: A BILL TO BE ENTITLED AN ACT TO CREATE A SEARCHABLE BUDGET DATABASE FOR STATE SPENDING. The General Assembly of North Carolina enacts: "Article 3E. "Taxpayer Transparency Act. **"§ 147-33.120. Findings and purpose.** The General Assembly finds that taxpayers should be able easily to access the details on how the State is spending their tax dollars and what performance results are achieved for those expenditures. It is the intent of the General Assembly, therefore, to direct the Office of State Budget and Management to create and maintain a searchable budget database Web site detailing where, for what purpose, and what results are achieved for all taxpayer investments in State government. '§ 147-33.121. Short title. This Article shall be known and may be cited as the "Taxpayer Transparency Act." "§ 147-33.122. Definitions. The following definitions apply in this Article: Agency. – A State department, office, board, commission, bureau, division, (1) institution, or institution of higher education. The term includes individual State agencies and programs, as well as those programs and activities that cross agency lines. The term also includes all elective offices in the executive, legislative, and judicial branch of State government. Director. - The Governor or the person in the Office of State Budget and (2) Management designated by the Governor to administer the provisions of this Article. (3) Entity or recipients. - The term includes all of the following but does not include an individual recipient of State assistance: A corporation. a. An association. b. A union. <u>c.</u> A limited liability company. d. A limited liability partnership. e. Any other legal business entity, including nonprofits. <u>f.</u> Grantees. g. <u>h.</u> Contractors.

The funding source of the revenue expended. 14 The budget program or activity of the expenditure. <u>e.</u> 15 A descriptive purpose for the funding action or expenditure. <u>f.</u> 16 The expected performance outcome for the funding action or <u>g.</u> 17 expenditure. 18 <u>h.</u> The past performance outcomes achieved for the funding action or 19 expenditure. 20 Any State audit or report relating to the entity or recipient of funds or <u>i.</u> 21 to the budget program, activity, or agency. Any other relevant information specified by the Office of State 22 <u>j.</u> 23 Budget and Management. State audit or report. - The term includes any audit or report issued by the 24 <u>(7)</u>
 - body relating to the entity or recipient of funds or the budget program or activity or agency.

"§ 147-33.123. Searchable budget database Web site created.

- By January 1, 2015, the Director shall develop and make publicly available a single, searchable budget database Web site including the required data for the 2013-2015 fiscal biennium. The Web site shall be given a unique and simplified Web site address. In addition to the information specified by G.S. 147-33.122 that shall be made accessible through the single, searchable budget database Web site, the Web site shall also provide, where possible, a hyperlink to the actual grants or contracts that is a funding action or expenditure.
- Each State agency that maintains a generally accessible Internet Web site or for which a generally accessible Internet Web site is maintained shall include a link on the front page of the agency's Internet Web site to the searchable budget database Web site.

"§ 147-33.124. Updates.

Effective July 1, 2015, the searchable budget database Web site shall be updated for each fiscal year not later than 30 days following the close of the fiscal year. In addition, the Director may update the searchable budget database Web site as new data becomes available. All State agencies shall provide to the Director all data that is required to be included in the searchable budget database Web site not later than 30 days after the data becomes available to the agency. The Director shall provide guidance to agency heads to ensure compliance with this section. By January 1, 2016, the Director shall add data for the budget for the 2011-2013 fiscal biennium to the searchable budget database Web site. Data for previous fiscal years may be added as available and as time permits. The Director shall ensure that all data added to the searchable budget database Web site remains accessible to the public for a minimum of 10 years.

"§ 147-33.125. Compliance with Article.

The Director shall not be considered in compliance with this Article if the data required for the searchable budget database Web site are not available in a searchable and aggregate manner
