7	SI	ECTION 1. G.S. 143B-426.39 reads as rewritten:		
8	"§ 143B-426.	<b>39.</b> Powers and duties of the State Controller.		
9	The State	Controller shall:

11	<u>(1</u>	8) Require a criminal history record check of any current or pr	cospective employee,	
12		volunteer, or contractor, which shall be conducted by t	he State Bureau of	
13		Investigation as provided in G.S. 143B-966. The criminal h	istory report shall be	
14		provided to the State Controller and is not a public record u	inder Chapter 132 of	
15		the General Statutes."		
16	SI	ECTION 2. Subpart D of Part 4 of Article 13 of Chapter 1	43B of the General	
17	Statutes is amended by adding a new section to read as follows:			
18	"§ 143B-966. Criminal record checks for the Office of State Controller.			
19	The Department of Public Safety may provide to the Office of State Controller from the State			
20	and National Repositories of Criminal Histories the criminal history of any current or prospective			
21	employee, volunteer, or contractor of the Office of State Controller. The Office of State Controller			
22	shall provide to the Department of Public Safety, along with the request, the fingerprints of the			
23	current or prospective employee, volunteer, or contractor, a form signed by the current or			
24		mployee, volunteer, or contractor consenting to the criminal reco		
25	fingerprints and other identifying information required by the State and National Repositories, and			
26	any additional information required by the Department of Public Safety. The fingerprints of the			
27		ospective employee, volunteer, or contractor shall be forwarded to		
28	Investigation for a search of the State's criminal history record file, and the State Bureau of			
29	Investigation shall forward a set of fingerprints to the Federal Bureau of Investigation for a			
30	national criminal history record check. The Office of State Controller shall keep all information			
31	obtained pursuant to this section confidential. The Department of Public Safety may charge a fee			
32	-	to offset the cost incurred by it to conduct a criminal record check under this section. The fee shall		
33		e actual cost of locating, editing, researching, and retrieving the i	nformation."	
34	Sl	ECTION 3. This act is effective when it becomes law.
