Short Title: Modernize Nursing Practice Act.

2 AN ACT UPDATING AND MODERNIZING THE NURSING PRACTICE ACT.
3 The General Assembly of North Carolina enacts:

4 SECTION 1. G.S. 90-171.20 reads as rewritten:
5 "§ 90-171.20. Definitions.

6 As used in this Article, unless the context requires otherwise:

7 (1) Advanced assessment. – The taking by an advanced practice registered nurse of
8 the history, physical, and psychological assessment of a patient's signs,
9 symptoms, pathophysiologic status, and psychosocial variations in the
10 determination of differential diagnoses and treatment.

11 (1a) Advanced practice registered nurse or APRN. – An individual licensed by the
12 Board as an advanced practice registered nurse within one of the following four
13 roles:

14 a. Nurse practitioner or NP.

15 b. Certified nurse midwife or CNM.

16 c. Clinical nurse specialist or CNS.

17 d. Certified registered nurse anesthetist or CRNA.

18 (1b) ~~"Board"~~ means the Board. – The North Carolina Board of Nursing.

19 (2) ~~"Health care provider"~~ means any Health care provider. – Any licensed health
20 care professional and any agent or employee of any health care institution,
21 health care insurer, health care professional school, or a member of any allied
22 health profession. For purposes of this Article, a person enrolled in a program
23 that prepares the person to be a licensed health care professional or an allied
24 health professional shall be deemed a health care provider.

25 (3) ~~"License"~~ means a License. – A permit issued by the Board to practice nursing
26 as an advanced practice registered nurse, as a registered nurse-nurse, or as a
27 licensed practical nurse, including a renewal or reinstatement thereof.

28 (3a) Nurse anesthesia activities. – Consist of the following activities, including
29 clinical activities:

30 a. Preanesthesia preparation and evaluation of the client, including the
31 following:

32 1. Performing a preoperative health assessment.

33 2. Recommending, requesting, and evaluating pertinent diagnostic
34 studies.

35 3. Selecting and administering preanesthetic medications.

- 1 b. Anesthesia induction, maintenance, and emergence of the client,
2 including the following:
- 3 1. Securing, preparing, and providing safety checks on all
4 equipment, monitors, supplies, and pharmaceutical agents used
5 for the administration of anesthesia.
 - 6 2. Selecting, implementing, and managing general anesthesia;
7 monitored anesthesia care; and regional anesthesia modalities,
8 including administering anesthetic and related pharmaceutical
9 agents, consistent with the client's needs and procedural
10 requirements.
 - 11 3. Performing tracheal intubation and extubation and providing
12 mechanical ventilation.
 - 13 4. Providing perianesthetic invasive and noninvasive monitoring,
14 recognizing abnormal findings, implementing corrective action,
15 and requesting consultation with appropriately qualified health
16 care providers as necessary.
 - 17 5. Managing the client's fluid, blood, electrolyte, and acid-base
18 balance.
 - 19 6. Evaluating the client's response during emergence from
20 anesthesia and implementing pharmaceutical and supportive
21 treatment to ensure the adequacy of client recovery from
22 anesthesia.
- 23 c. Postanesthesia care of the client, including the following:
- 24 1. Providing postanesthesia follow-up care, including evaluating
25 the client's response to anesthesia, recognizing potential
26 anesthetic complications, implementing corrective actions, and
27 requesting consultation with appropriately qualified health care
28 professionals as necessary.
 - 29 2. Initiating and administering respiratory support to ensure
30 adequate ventilation and oxygenation in the immediate
31 postanesthesia period.
 - 32 3. Initiating and administering pharmacological or fluid support of
33 the cardiovascular system during the immediate postanesthesia
34 period.
 - 35 4. Documenting all aspects of nurse anesthesia care and reporting
36 the client's status, perianesthetic course, and anticipated
37 problems to an appropriately qualified postanesthetic health care
38 provider who assumes the client's care following anesthesia
39 consistent with 21 NCAC 36 .0224(f).
 - 40 5. Releasing clients from the postanesthesia care or surgical setting
41 as per established agency policy.
- 42 d. Other clinical activities for which the qualified registered nurse
43 anesthetist may accept responsibility, including all of the following:
- 44 1. Inserting central vascular access catheters and epidural catheters.
 - 45 2. Identifying, responding to, and managing emergency situations,
46 including initiating and participating in cardiopulmonary
47 resuscitation.
 - 48 3. Providing consultation related to respiratory and ventilator care
49 and implementing such care according to established policies
50 within the practice setting.

4. Initiating and managing pain relief therapy utilizing pharmaceutical agents, regional anesthetic techniques and other accepted pain relief modalities according to established policies and protocols within the practice setting.

For purposes of this Article, these activities do not constitute the prescribing of a medical treatment regimen or the making of a medical diagnosis.

(4) ~~"Nursing" is a~~Nursing. – A dynamic discipline which includes the assessing, caring, counseling, teaching, referring and implementing of prescribed treatment in the maintenance of health, prevention and management of illness, injury, disability or the achievement of a dignified death. It is ministering to; assisting; and sustained, vigilant, and continuous care of those acutely or chronically ill; supervising patients during convalescence and rehabilitation; the supportive and restorative care given to maintain the optimum health level of individuals, groups, and communities; the supervision, teaching, and evaluation of those who perform or are preparing to perform these functions; and the administration of nursing programs and nursing services. For purposes of this Article, the administration of required lethal substances or any assistance whatsoever rendered with an execution under Article 19 of Chapter 15 of the General Statutes does not constitute nursing.

(5) ~~"Nursing program" means any~~Nursing program. – Any educational program in North Carolina offering to prepare persons to meet the educational requirements for licensure under this Article. Article as a registered nurse or a licensed practical nurse.

(6) ~~"Person" means an~~Person. – An individual, corporation, partnership, association, unit of government, or other legal entity.

(6a) Population focus. – With respect to APRN practice, includes one of the following areas of focus:

- a. The family or the individual across the life span.
- b. Adult gerontology.
- c. Neonatal.
- d. Pediatrics.
- e. Women's health or gender-related issues.
- f. Psychiatric or mental health.

(6b) Practice of nursing as an advanced practice registered nurse or APRN. – In addition to the RN scope of practice and within the APRN role and population foci, also consists of the following six components:

- a. Conducting an advanced assessment.
- b. Delegating and assigning therapeutic measures to assistive personnel.
- c. Performing other acts that require education and training consistent with professional standards and commensurate with the APRN's education, certification, demonstrated competencies, and experience.
- d. Complying with the requirements of this Article and rendering quality advanced nursing care.
- e. Recognizing limits of knowledge and experience.
- f. Planning for the management of situations beyond the APRN's expertise.

(6c) Practice of nursing as a certified nurse midwife or CNM. – Consists of the following four components:

- a. The management, diagnosis, and treatment of women's primary health care, including pregnancy, childbirth, postpartum period, care of the

- 1 newborn, family planning, partner care management relating to sexual
2 health, and gynecological care of women across the life span.
- 3 b. Ordering, performing, supervising, and interpreting diagnostic studies.
4 c. Prescribing pharmacologic and nonpharmacologic therapies.
5 d. Consulting with or referring to other health care providers as warranted
6 by the needs of the patient.
- 7 (6d) Practice of nursing as a certified registered nurse anesthetist or CRNA. –
8 Consists of the performance of nurse anesthesia activities and related services,
9 in collaboration with a physician, dentist, podiatrist, or other lawfully qualified
10 health care provider, including the following:
- 11 a. Selecting, ordering, and administering drugs and therapeutic devices to
12 facilitate diagnostic, therapeutic, and surgical procedures.
13 b. Ordering, performing, supervising, and interpreting diagnostic studies.
14 c. Consulting with or referring to other health care providers as warranted
15 by the needs of the patient.
- 16 (6e) Practice of nursing as a clinical nurse specialist or CNS. – Consists of the
17 following eight components:
- 18 a. The diagnosis and treatment of health and illness states.
19 b. Disease management.
20 c. Prescribing nonpharmacologic therapies.
21 d. Ordering, performing, supervising, and interpreting diagnostic studies.
22 e. Preventing of illness and risk behaviors.
23 f. Nursing care for individuals, families, and communities.
24 g. Consulting with or referring to other health care providers as warranted
25 by the needs of the patient.
26 h. Integrating care across the continuum to improve patient outcomes.
- 27 (6f) Practice of nursing as a nurse practitioner or NP. – Consists of the following six
28 components:
- 29 a. Health promotion, disease prevention, health education, and counseling.
30 b. Providing health assessment and screening activities.
31 c. Diagnosing, treating, and facilitating patients' management of their
32 acute and chronic illnesses and diseases.
33 d. Ordering, performing, supervising, and interpreting diagnostic studies.
34 e. Prescribing pharmacologic and nonpharmacologic therapies.
35 f. Consulting with or referring to other health care providers as warranted
36 by the needs of the patient.
- 37 (7) ~~The "practice of nursing by a registered nurse" consists~~ Practice of nursing by a
38 registered nurse. – Consists of the following 10 components:
- 39 a. Assessing the patient's physical and mental health, including the
40 patient's reaction to illnesses and treatment regimens.
41 b. Recording and reporting the results of the nursing assessment.
42 c. Planning, initiating, delivering, and evaluating appropriate nursing acts.
43 d. Teaching, assigning, delegating to or supervising other personnel in
44 implementing the treatment regimen.
45 e. Collaborating with other health care providers in determining the
46 appropriate health care for a patient ~~but, subject to the provisions of~~
47 ~~G.S. 90-18.2, not prescribing a medical treatment regimen or making a~~
48 ~~medical diagnosis, except under supervision of a licensed~~
49 ~~physician-patient.~~

- 1 f. Implementing the treatment and pharmaceutical regimen prescribed or
- 2 ordered by any person authorized by State law to prescribe or order the
- 3 regimen.
- 4 g. Providing teaching and counseling about the patient's health.
- 5 h. Reporting and recording the plan for care, nursing care given, and the
- 6 patient's response to that care.
- 7 i. Supervising, teaching, and evaluating those who perform or are
- 8 preparing to perform nursing functions and administering nursing
- 9 programs and nursing services.
- 10 j. Providing for the maintenance of safe and effective nursing care,
- 11 whether rendered directly or indirectly.
- 12 (8) ~~The "practice of nursing by a licensed practical nurse" consists~~ Practice of
- 13 nursing by a licensed practical nurse. – Consists of the following seven
- 14 components:
- 15 a. Participating in the assessment of the patient's physical and mental
- 16 health, including the patient's reaction to illnesses and treatment
- 17 regimens.
- 18 b. Recording and reporting the results of the nursing assessment.
- 19 c. Participating in implementing the health care plan developed by the
- 20 registered nurse and/or prescribed by any person authorized by State
- 21 law to prescribe such a plan, by performing tasks assigned or delegated
- 22 by and performed under the supervision or under orders or directions of
- 23 a registered nurse, physician licensed to practice medicine, dentist, or
- 24 other person authorized by State law to provide the supervision.
- 25 c1. Assigning or delegating nursing interventions to other qualified
- 26 personnel under the supervision of the registered nurse.
- 27 d. Participating in the teaching and counseling of patients as assigned by a
- 28 registered nurse, physician, or other qualified professional licensed to
- 29 practice in North Carolina.
- 30 e. Reporting and recording the nursing care rendered and the patient's
- 31 response to that care.
- 32 f. Maintaining safe and effective nursing care, whether rendered directly
- 33 or indirectly."

SECTION 2. G.S. 90-18(c) reads as rewritten:

35 "(c) The following shall not constitute practicing medicine or surgery as defined in this
36 Article:

37 ...
38 (7) ~~The practice of midwifery as defined in G.S. 90-178.2.~~

39 ...
40 (14a) The practice of nursing by a certified registered nurse anesthetist or CRNA as
41 defined in G.S. 90-171.20.

SECTION 3. G.S. 90-29(b) reads as rewritten:

44 "(b) A person shall be deemed to be practicing dentistry in this State who does, undertakes
45 or attempts to do, or claims the ability to do any one or more of the following acts or things which,
46 for the purposes of this Article, constitute the practice of dentistry:

- 47 ...
- 48 (6) Administers an anesthetic of any kind in the treatment of dental or oral diseases
- 49 or physical conditions, or in preparation for or incident to any operation within
- 50 the oral cavity; provided, however, that this subsection shall not apply to a
- 51 ~~lawfully qualified~~ certified registered nurse anesthetist who administers such

1 anesthetic ~~under the supervision and direction of~~ in collaboration with a licensed
2 dentist or ~~physician; physician~~ pursuant to G.S. 90-171.20(6d);

4 **SECTION 4.(a)** G.S. 90-171.21 reads as rewritten:

5 **"§ 90-171.21. Board of Nursing; composition; selection; vacancies; qualifications; term of**
6 **office; compensation.**

7 (a) The Board shall consist of 14 members. Eight members shall be registered nurses.
8 Three members shall be licensed practical nurses. Three members shall be representatives of the
9 public.

10 (b) Selection. – The North Carolina Board of Nursing shall conduct an election each year
11 to fill vacancies of nurse members of the Board scheduled to occur during the next year.
12 Nominations of candidates for election of registered nurse members shall be made by written
13 petition signed by not less than 10 registered nurses eligible to vote in the election. Nominations of
14 candidates for election of licensed practical nurse members shall be made by written petition
15 signed by not less than 10 licensed practical nurses eligible to vote in the election. Every
16 registered nurse holding an active advanced practice registered nurse license shall be eligible to
17 vote in the election of the advanced practice registered nurse Board member. Every licensed
18 registered nurse holding an active license shall be eligible to vote in the election of registered
19 nurse board members. Every licensed practical nurse holding an active license shall be eligible to
20 vote in the election of licensed practical nurse board members. The list of nominations shall be
21 filed with the Board after January 1 of the year in which the election is to be held and no later than
22 midnight of the first day of April of such year. Before preparing ballots, the Board shall notify
23 each person who has been duly nominated of the person's nomination and request permission to
24 enter the person's name on the ballot. A member of the Board who is nominated for reelection and
25 who does not withdraw the member's name from the ballot is disqualified to participate in
26 conducting the election. Elected members shall begin their term of office on January 1 of the year
27 following their election.

28 Nominations of persons to serve as public members of the Board may be made to the
29 Governor or the General Assembly by any citizen or group within the State. The Governor shall
30 appoint one public member to the Board, and the General Assembly shall appoint two public
31 members to the Board. Of the public members appointed by the General Assembly, one shall be
32 appointed by the General Assembly upon the recommendation of the President Pro Tempore of
33 the Senate, and one shall be appointed by the General Assembly upon the recommendation of the
34 Speaker of the House of Representatives.

35 Board members shall be commissioned by the Governor upon their election or appointment.

36 (c) Vacancies. – All unexpired terms of Board members appointed by the General
37 Assembly shall be filled within 45 days after the term is vacated. The Governor shall fill all other
38 unexpired terms on the Board within 30 days after the term is vacated. For vacancies of registered
39 nurse or licensed practical nurse members, ~~the Governor shall appoint the person who received the~~
40 ~~next highest number of votes to those elected members at the most recent election for board~~
41 ~~members.~~ Board shall notify the person who received the next highest number of votes in the
42 election when the vacating member was elected in order to fulfill the remainder of the unexpired
43 term. If the replacement Board member no longer meets the qualifications under subsection (d) of
44 this section, the Board shall notify the person receiving the next highest number of votes in the
45 election when the vacating member was elected. Appointees shall serve the remainder of the
46 unexpired term and until their successors have been duly elected or appointed and qualified.

47 (d) Qualifications. – Of the eight registered nurse members on the Board, one shall be a
48 nurse administrator employed by a hospital or a hospital system, who shall be accountable for the
49 administration of nursing services and not directly involved in patient care; one shall be an
50 individual who meets the requirements to practice as ~~a certified registered nurse anesthetist, a~~
51 ~~certified nurse midwife, a clinical nurse specialist, or a nurse practitioner;~~ an APRN; two shall be

1 staff nurses, defined as individuals who are primarily involved in direct patient care regardless of
2 practice setting; one shall be an at-large registered nurse who meets the requirements of
3 sub-subdivisions (1) b., e., f., and g. of this subsection, but is not currently an educator in a
4 program leading to licensure or any other degree-granting program; and three shall be nurse
5 educators. Minimum ongoing employment requirements for every registered nurse and licensed
6 practical nurse shall include continuous employment equal to or greater than fifty percent (50%) of
7 a full-time position that meets the criteria for the specified Board member position. Of the three
8 nurse educators, one shall be a practical nurse educator, one shall be an associate degree or
9 diploma nurse educator, and one shall be a baccalaureate or higher degree nurse educator. All
10 nurse educators shall meet the minimum education requirement as established by the Board's
11 education program standards for nurse faculty. Candidates eligible for election to the Board as
12 nurse educators are not eligible for election as the at-large member.

13 (1) Except for the at-large member, every registered nurse member shall meet the
14 following criteria:

- 15 a. Hold ~~a current, an active,~~ unencumbered license to practice as a
16 registered nurse in North Carolina.
- 17 a1. Be a resident of North Carolina.
- 18 b. Have a minimum of five years of experience as a registered nurse.
- 19 c. Have been engaged continuously in a position that meets the criteria for
20 the specified Board position for at least three years immediately
21 preceding election.
- 22 d. Show evidence that the employer of the registered nurse is aware that
23 the nurse intends to serve on the Board.
- 24 e. Have no disciplinary history with the Board or any other licensing board
25 in this State or another state within the 10 years preceding the nurse's
26 appointment to the Board.
- 27 f. Have no history of felony convictions of any kind.
- 28 g. Have no misdemeanor convictions related to the practice of nursing.

29 (2) Every licensed practical nurse member shall meet the following criteria:

- 30 a. Hold ~~a current, an active,~~ unencumbered license to practice as a licensed
31 practical nurse in North Carolina.
- 32 a1. Be a resident of North Carolina.
- 33 c. Have a minimum of five years of experience as a licensed practical
34 nurse.
- 35 d. Have been engaged continuously in the position of a licensed practical
36 nurse for at least three years immediately preceding election.
- 37 e. Show evidence that the employer of the licensed practical nurse is aware
38 that the nurse intends to serve on the Board.
- 39 f. Have no disciplinary history with the Board or any other licensing board
40 in this State or another state within the 10 years preceding the nurse's
41 appointment to the Board.
- 42 g. Have no history of felony convictions of any kind.
- 43 h. Have no misdemeanor convictions related to the practice of nursing.

44 (3) A public member ~~appointed by the Governor~~ shall not be a ~~provider of health~~
45 ~~services~~ licensed nurse or licensed health care professional or employed ~~in the~~
46 ~~health services field.~~ No by a health care institution, health care insurer, or
47 health care professional school. Additionally, no public member appointed by
48 the Governor or person in the public member's immediate family as defined by
49 G.S. 90-405(8) shall be currently employed as a licensed nurse or been
50 previously employed as a licensed nurse.

- 1 (4) ~~The nurse practitioner, nurse anesthetist, nurse midwife, or clinical nurse~~
2 ~~specialist advanced practice registered nurse~~ member shall be ~~recognized~~
3 ~~licensed~~ by the Board as ~~a registered nurse~~ an advanced practice registered
4 ~~nurse~~ who meets the following criteria:
- 5 a. ~~Has graduated from or completed a graduate level advanced practice~~
6 ~~nursing education program accredited by a national accrediting body.~~
- 7 b. ~~Maintains current certification or recertification from a national~~
8 ~~credentialing body approved by the Board or meets other requirements~~
9 ~~established by rules adopted by the Board.~~
- 10 c. ~~Practices in a manner consistent with rules adopted by the Board and~~
11 ~~other applicable law.~~
- 12 d. Holds an active, unencumbered license to practice as an advanced
13 practice registered nurse in North Carolina.
- 14 e. Is a resident of North Carolina.
- 15 f. Has a minimum of five years of experience as an advanced practice
16 registered nurse.
- 17 g. Has been engaged continuously in the position of an advanced practice
18 registered nurse for at least three years immediately preceding election.
- 19 h. Provides evidence that the employer of the advanced practice registered
20 nurse is aware that the nurse intends to serve on the Board.
- 21 i. Has no disciplinary history with the Board or any other licensing board
22 in this State or another state within the 10 years preceding the nurse's
23 appointment to the Board.
- 24 j. Has no history of felony convictions of any kind.
- 25 k. Has no misdemeanor convictions related to the practice of nursing.

26 (e) Term. – Members of the Board shall serve four-year staggered terms. No member shall
27 serve more than two consecutive four-year terms or eight consecutive ~~years after January 1,~~
28 ~~2005 years.~~

29 (f) Removal. – The Board may remove any of its members for neglect of duty,
30 incompetence, or unprofessional conduct. A member subject to disciplinary proceedings shall be
31 disqualified from Board business until the charges are resolved.

32 (g) Reimbursement. – Board members are entitled to receive compensation and
33 reimbursement as authorized by G.S. 93B-5."

34 **SECTION 4.(b)** G.S. 90-171.21(a), as amended by this act, applies to members newly
35 appointed to the Board of Nursing after the effective date of this act.

36 **SECTION 5.** G.S. 90-171.23(b) reads as rewritten:

37 "(b) Duties, powers. The Board is empowered to:

- 38 (1) Administer this Article.
- 39 (2) Issue its interpretations of this Article.
- 40 (3) Adopt, amend or repeal rules and regulations as may be necessary to carry out
41 the provisions of this Article.
- 42 (4) Establish qualifications of, employ, and set the compensation of an executive
43 officer who shall be a registered nurse ~~and who holds an active North Carolina~~
44 license and who shall not be a member of the Board.
- 45 (5) Employ and fix the compensation of other personnel that the Board determines
46 are necessary to carry into effect this Article and incur other expenses necessary
47 to effectuate this Article.
- 48 (6) Examine, license, and renew the licenses of duly qualified applicants for
49 licensure.
- 50 (7) Cause the prosecution of all persons violating this Article.

- 1 (8) Establish standards to be met by the students, and to pertain to faculty,
2 curricula, facilities, resources, and administration for any nursing program
3 leading to initial licensure as a registered nurse or a licensed practical nurse as
4 provided in G.S. 90-171.38.
- 5 (9) Review all nursing programs leading to initial licensure as a registered nurse or
6 a licensed practical nurse at least every eight years or more often as considered
7 necessary by the Board or program director.
- 8 (10) Grant or deny approval for nursing programs as provided in G.S. 90-171.39.
- 9 (11) ~~Upon request, grant~~ Grant or deny approval of continuing education programs
10 for nurses as provided in G.S. 90-171.42.
- 11 (12) Keep a record of all proceedings and make an annual summary of all actions
12 available.
- 13 (13) Appoint, as necessary, advisory committees which may include persons other
14 than Board members to deal with any issue under study.
- 15 (14) ~~Appoint and maintain a subcommittee of the Board to work jointly with the~~
16 ~~subcommittee of the North Carolina Medical Board to develop rules and~~
17 ~~regulations to govern the performance of medical acts by registered nurses and~~
18 ~~to determine reasonable fees to accompany an application for approval or~~
19 ~~renewal of such approval as provided in G.S. 90-8.2. The fees and rules~~
20 ~~developed by this subcommittee shall govern the performance of medical acts~~
21 ~~by registered nurses and shall become effective when they have been adopted~~

27 purposes of this ~~Article.~~ Article, provided that the fees are consistent with
28 G.S. 90-171.27.
- 29 (16) Adopt a seal containing the name of the Board for use on all certificates,
30 licenses, and official reports issued by it.
- 31 (17) Enter into interstate compacts to facilitate the practice and regulation of
32 nursing. APRNs, RNs, and LPNs.
- 33 (18) ~~Establish programs for aiding in the recovery and rehabilitation of nurses who~~
34 ~~experience chemical addiction or abuse or mental or physical disabilities and~~
35 ~~programs for monitoring such nurses for safe practice.~~ monitoring the treatment,
36 recovery, and safe practice of nurses experiencing substance use disorders,
37 mental health disorders, or physical conditions impacting the ability to deliver
38 safe care.

7 (2) Any arrest for driving while impaired or driving under the influence.

8 (3) Any arrest or indictment for the possession, use, or sale of any controlled
9 substance.

10 (g) The Board, its members, and staff may release confidential or nonpublic information to
11 any health care licensure board in this State or another state or authorized Department of Health
12 and Human Services personnel with enforcement or investigative responsibilities about the
13 issuance, denial, annulment, suspension, or revocation of a license, or the voluntary surrender of a
14 license by a licensee of the Board, including the reasons for the action, or an investigative report
15 made by the Board. The Board shall notify the licensee within 60 days after the information is
16 transmitted. A summary of the information that is being transmitted shall be furnished to the
17 licensee. If the licensee requests in writing within 30 days after being notified that the information
18 has been transmitted, the licensee shall be furnished a copy of all information so transmitted. The
19 notice or copies of the information shall not be provided if the information relates to an ongoing
20 criminal investigation by any law enforcement agency or authorized Department of Health and
21 Human Services personnel with enforcement or investigative responsibilities.

22 "**§ 90-171.37C. Service of notices.**

23 Any notice required by this Article may be served either personally by an employee of the
24 Board or by an officer authorized by law to serve process, or by registered or certified mail, return
25 receipt requested, directed to the licensee or applicant at his or her last known address as shown by
26 the records of the Board. If notice is served personally, it shall be deemed to have been served at
27 the time when the officer or employee of the Board delivers the notice to the person addressed or
28 delivers the notice at the licensee's or applicant's last known address as shown by records of the
29 Board with a person of suitable age and discretion then residing therein. Where notice is served in
30 a manner authorized by Rule 4(j) of the N.C. Rules of Civil Procedure, it shall be deemed to have
31 been served on the date borne by the return receipt showing delivery of the notice to the licensee's
32 or applicant's last known address as shown by the records of the Board, regardless of whether the
33 notice was actually received or whether the notice was unclaimed or undeliverable for any
34 reason."

35 **SECTION 20.** G.S. 90-171.39 reads as rewritten:

36 "**§ 90-171.39. Approval.**

37 The Board shall designate persons to ~~survey~~ review proposed nursing programs, including the
38 ~~clinical facilities programs~~. The persons designated by the Board shall submit a ~~written~~ report of
39 the ~~survey~~ review to the ~~Board~~ Board in the manner prescribed by the Board. If in the opinion of
40 the Board the standards for approved nursing education are met, the program shall be given
41 approval."

42 **SECTION 21.** G.S. 90-171.40 reads as rewritten:

43 "**§ 90-171.40. Ongoing approval.**

44 The Board shall review all nursing programs in the State at least every ~~eight~~ 10 years or more
45 often as considered necessary. If the Board determines that any approved nursing program does
46 not meet or maintain the standards required by the Board, the Board shall give written notice
47 specifying the deficiencies to the institution responsible for the program. The Board shall
48 ~~withdraw~~ evaluate and take appropriate action, up to and including withdrawing approval from a
49 program that fails to correct deficiencies within a reasonable time. The Board shall publish
50 ~~annually~~ a list of nursing programs in this State showing their approval status."

51 **SECTION 22.** G.S. 90-171.42(a) reads as rewritten:

1 **"§ 90-171.42. Continuing education programs.**

2 (a) ~~Upon request, the~~The Board shall grant approval to continuing education programs
3 upon a finding that the program offers an educational experience designed to enhance the practice
4 of nursing."

5 **SECTION 23.** G.S. 90-171.43 reads as rewritten:

6 **"§ 90-171.43. License required.**

7 (a) No person shall practice or offer to practice as ~~an advanced practice registered nurse,~~
8 ~~registered nurse~~nurse, or licensed practical nurse, or use the word "nurse" as a title for herself or
9 himself, or use an abbreviation to indicate that the person is ~~an advanced practice registered~~
10 ~~nurse,~~ registered nurse, or licensed practical nurse, unless the person is currently licensed as
11 ~~an advanced practice registered nurse,~~ registered nurse, or licensed practical nurse as
12 provided by this Article. If the word "nurse" is part of a longer title, such as "nurse's aide", a
13 person who is entitled to use that title shall use the entire title and may not abbreviate the title to
14 "nurse". This Article shall not, however, be construed to prohibit or limit the following:

- 15 (1) The performance by any person of any act for which that person holds a license
16 issued pursuant to North Carolina law;
- 17 (2) The clinical practice by students enrolled in approved nursing programs,
18 continuing education programs, or refresher courses under the supervision of
19 qualified faculty;
- 20 (3) The performance of nursing performed by persons who hold a temporary
21 license issued pursuant to G.S. 90-171.33;
- 22 (4) The delegation to any person, including a member of the patient's family, by a
23 physician licensed to practice medicine in North Carolina, a licensed dentist or
24 registered nurse of those patient-care services which are routine, repetitive,
25 limited in scope that do not require the professional judgment of a registered
26 nurse or licensed practical nurse;
- 27 (5) Assistance by any person in the case of emergency.

28 Any person permitted to practice nursing without a license as provided in subdivision (2) or
29 (3) of this section shall be held to the same standard of care as any licensed nurse.

30 (b) The abbreviations for the APRN designation of a certified nurse midwife, a clinical
31 nurse specialist, a certified registered nurse anesthetist, and a nurse practitioner shall be APRN,
32 plus the role title, i.e. CNM, CNS, CRNA, and NP.

33 (c) It shall be unlawful for any person to use the title "APRN" or "APRN" plus their
34 respective role titles, the role title alone, authorized abbreviations, or any other title that would
35 lead a person to believe the individual is an APRN, unless permitted by this act.

36 (d) The Board shall have the authority to promulgate rules to enforce the provisions of this
37 section."

38 **SECTION 24.** G.S. 90-171.43A reads as rewritten:

39 **"§ 90-171.43A. Mandatory employer verification of licensure status.**

40 (a) Before hiring an advanced practice registered nurse, a registered ~~nurse~~nurse, or a
41 licensed practical nurse in North Carolina, a health care facility shall verify that the applicant has a
42 current, valid license to practice nursing pursuant to G.S. 90-171.43.

43 (b) For purposes of this section, "health care facility" means:

- 44 (1) Facilities described in G.S. 131E-256(b).
- 45 (2) Public health departments, physicians' offices, ambulatory care facilities, and
46 rural health clinics."

47 **SECTION 25.** G.S. 90-171.44 reads as rewritten:

48 **"§ 90-171.44. Prohibited acts.**

49 It shall be a violation of this Article, and subject to action under G.S. 90-171.37, for any
50 person to:

- 1 (1) Sell, fraudulently obtain, or fraudulently furnish any nursing diploma or aid or
2 abet therein.
- 3 (2) Practice nursing under cover of any fraudulently obtained license.
- 4 (3) Practice nursing without a license. ~~This subdivision shall not be construed to~~
5 ~~prohibit any licensed registered nurse who has successfully completed a~~
6 ~~program established under G.S. 90-171.38(b) from conducting medical~~
7 ~~examinations or performing procedures to collect evidence from the victims of~~
8 ~~offenses described in that subsection.~~
- 9 (3a) Refer to himself or herself as an advanced practice registered nurse; or refer to
10 himself or herself as any of the four roles of advanced practice registered
11 nurses, a registered nurse, or a licensed practical nurse; or use the abbreviations
12 "APRN", "CNM", "CNS", "CRNA", "NP", "RN", and "LPN".
- 13 (4) Conduct a nursing program or a refresher course for activation of a license, that
14 is not approved by the Board.
- 15 (5) Employ unlicensed persons to practice nursing."

16 **SECTION 26.** G.S. 90-171.47 reads as rewritten:

17 **"§ 90-171.47. Reports: immunity from suit.**

18 Any person who has reasonable cause to suspect misconduct or incapacity of a licensee or who
19 has reasonable cause to suspect that any person is in violation of this Article, including those
20 actions specified in G.S. 90-171.37(1) through (8), G.S. 90-171.43, and G.S. 90-171.44, shall
21 report the relevant facts to the ~~Board~~Board in a timely manner. Upon receipt of such
22 ~~charge information~~ or upon its own initiative, the Board ~~may give notice of an administrative~~
23 ~~hearing or may, after diligent investigation, dismiss unfounded charges.~~shall conduct an
24 investigation and prosecute all persons violating this Article pursuant to G.S. 90-171.23(b)(7).
25 Any person making a report pursuant to this section shall be immune from any criminal
26 prosecution or civil liability resulting therefrom unless such person knew the report was false or
27 acted in bad faith or reckless disregard of whether the report was false."

28 **SECTION 27.** G.S. 90-171.48 reads as rewritten:

29 **"§ 90-171.48. Criminal history record checks of applicants for licensure.**

30 (a) Definitions. – The following definitions shall apply in this section:

- 31 (1) Applicant. – A person applying for ~~initial~~ licensure as ~~an~~ an advanced practice
32 registered nurse, registered nurse, or licensed practical nurse either by
33 examination pursuant to G.S. 90-171.29 or G.S. 90-171.30 or without
34 examination pursuant to G.S. 90-171.32. The term "applicant" shall also include
35 a person applying for renewal of licensure pursuant to G.S. 90-171.34,
36 reinstatement of licensure pursuant to G.S. 90-171.35 or returning to active
37 status pursuant to G.S. 90-171.36 as a registered nurse or licensed practical
38 nurse. Additionally, the term "applicant" shall also apply to a person applying
39 for licensure pursuant to G.S. 90-171.36B, renewal for licensure, or
40 reinstatement for licensure pursuant to G.S. 90-171.36C as an advanced
41 practice registered nurse.
- 42 (2) Criminal history. – A history of conviction of a State crime, whether a
43 misdemeanor or felony, that bears on an applicant's fitness for licensure to
44 practice nursing. The crimes include the criminal offenses set forth in any of the
45 following Articles of Chapter 14 of the General Statutes: Article 5,
46 Counterfeiting and Issuing Monetary Substitutes; Article 5A, Endangering
47 Executive and Legislative Officers; Article 6, Homicide; Article 7A, Rape and
48 Other Sex Offenses; Article 8, Assaults; Article 10, Kidnapping and Abduction;
49 Article 13, Malicious Injury or Damage by Use of Explosive or Incendiary
50 Device or Material; Article 14, Burglary and Other Housebreakings; Article 15,
51 Arson and Other Burnings; Article 16, Larceny; Article 17, Robbery; Article

1 18, Embezzlement; Article 19, False Pretenses and Cheats; Article 19A,
2 Obtaining Property or Services by False or Fraudulent Use of Credit Device or
3 Other Means; Article 19B, Financial Transaction Card Crime Act; Article 20,
4 Frauds; Article 21, Forgery; Article 26, Offenses Against Public Morality and
5 Decency; Article 26A, Adult Establishments; Article 27, Prostitution; Article
6 28, Perjury; Article 29, Bribery; Article 31, Misconduct in Public Office;
7 Article 35, Offenses Against the Public Peace; Article 36A, Riots, Civil
8 Disorders, and Emergencies; Article 39, Protection of Minors; Article 40,
9 Protection of the Family; Article 59, Public Intoxication; and Article 60,
10 Computer-Related Crime. The crimes also include possession or sale of drugs
11 in violation of the North Carolina Controlled Substances Act in Article 5 of
12 Chapter 90 of the General Statutes and alcohol-related offenses including sale
13 to underage persons in violation of G.S. 18B-302 or driving while impaired in
14 violation of G.S. 20-138.1 through G.S. 20-138.5.

15 (b) All applicants for licensure ~~shall~~ shall, if requested by the Board, consent to a criminal
16 history record check. Refusal to consent to a criminal history record check may constitute grounds
17 for the Board to deny licensure to an applicant. The Board shall ensure that the State and national
18 criminal history of an applicant applying for initial licensure as a registered nurse or licensed
19 practical nurse either by examination pursuant to G.S. 90-171.29 or G.S. 90-171.30 or without
20 examination pursuant to G.S. 90-171.32 is checked. The Board may request a criminal history
21 record check for applicants applying for reinstatement of licensure pursuant to G.S. 90-171.35 or
22 returning to active status pursuant to G.S. 90-171.36 as a registered nurse or licensed practical
23 nurse.

24 The Board shall be responsible for providing to the North Carolina Department of Public
25 Safety the fingerprints of the applicant to be checked, a form signed by the applicant consenting to
26 the criminal record check and the use of fingerprints and other identifying information required by
27 the State or National Repositories, and any additional information required by the Department of
28 Public Safety. The Board shall keep all information obtained pursuant to this section confidential.

29 (c) If an applicant's criminal history record check reveals one or more convictions listed
30 under subsection (a)(2) of this section, the conviction shall not automatically bar licensure. The
31 Board shall consider all of the following factors regarding the conviction:

- 32 (1) The level of seriousness of the crime.
- 33 (2) The date of the crime.
- 34 (3) The age of the person at the time of the conviction.
- 35 (4) The circumstances surrounding the commission of the crime, if known.
- 36 (5) The nexus between the criminal conduct of the person and the job duties of the
37 position to be filled.
- 38 (6) The person's prison, jail, probation, parole, rehabilitation, and employment
39 records since the date the crime was committed.
- 40 (7) The subsequent commission by the person of a crime listed in subsection (a) of
41 this section.

42 If, after reviewing the factors, the Board determines that the grounds set forth in subsections (1),
43 (2), (3), (4), (5), or (6) of G.S. 90-171.37 exist, the Board may deny licensure of the applicant. The
44 Board may disclose to the applicant information contained in the criminal history record check
45 that is relevant to the denial. The Board shall not provide a copy of the criminal history record
46 check to the applicant. The applicant shall have the right to appear before the Board to appeal the
47 Board's decision. However, an appearance before the full Board shall constitute an exhaustion of
48 administrative remedies in accordance with Chapter 150B of the General Statutes.

49 (d) Limited immunity. – The Board, its officers and employees, acting in good faith and in
50 compliance with this section, shall be immune from civil liability for denying licensure to an
51 applicant based on information provided in the applicant's criminal history record check."

1 **SECTION 28.** Article 9A of Chapter 90 of the General Statutes is amended by adding
2 a new section to read:

3 **"§ 90-171.49. Disasters and emergencies.**

4 In the event of an occurrence that the Governor of the State of North Carolina has declared a
5 state of emergency, or in the event of an occurrence for which a county or municipality has
6 enacted an ordinance to deal with states of emergency under G.S. 166A-19.31, or to protect the
7 public health, safety, or welfare of its citizens under Article 22 of Chapter 130A of the General
8 Statutes, G.S. 160A-174(a) or G.S. 153A-121(a), as applicable, the Board may waive the
9 requirements of this Article in order to permit the provision of emergency health services to the
10 public."

11 **SECTION 29.** G.S. 90-171.28 and Article 10A of Chapter 90 of the General Statutes
12 are repealed.

13 **SECTION 30.** This act becomes effective January 1, 2018.
