6 Wednesday, October 25, 2023, they stand adjourned to reconvene on Wednesday, November 29,
7 2023, at 12:00 noon.

8 **SECTION 1.(b)** During the regular session that reconvenes on Wednesday,
9 November 29, 2023, only the following matters may be considered:

44 of an occupational licensing board for fiscal year 2024-2025 and (ii) bills
45 authorizing a fee for a unit of State government or political subdivision of the
46 State, provided that the bill must be submitted to the Bill Drafting Division of
47 the Legislative Services Office no later than 4:00 P.M. Monday, April 15,
48 2024, and must be introduced in the House of Representatives or filed for
49 introduction in the Senate no later than 4:00 P.M. Thursday, May 2, 2024.
- 50 (2) Bills:

- 1 a. Proposing an amendment or amendments to the North Carolina
2 Constitution and containing no other matter.
- 3 b. Proposing an amendment or amendments to the North Carolina
4 Constitution and containing no other matter other than statutory
5 conforming changes to implement such bills.
- 6 c. Solely making statutory and transitional changes to implement bills
7 under sub-subdivision a. of this subdivision.
- 8 (3) Bills and resolutions introduced in 2023 (i) that passed third reading in 2023
9 in the house in which introduced, were received in the other house in
10 accordance with Senate Rule 41 or House Rule 31.1(h), as appropriate, and
11 not disposed of in the other house by tabling, unfavorable committee report,
12 indefinite postponement, or failure to pass any reading, and which do not
13 violate the rules of the receiving house or (ii) not subject to the deadline set
14 forth in Senate Rule 41 or House Rule 31.1(h), as appropriate.
- 15 (4) Bills and resolutions implementing the recommendations of:
 - 16 a. Study commissions, authorities, and statutory commissions authorized
17 or directed to report to the 2023 Regular Session.
 - 18 b. The General Statutes Commission, the Courts Commission, or any
19 commission created under Chapter 120 of the General Statutes that is
20 authorized or directed to report to the General Assembly.
 - 21 c. The House Ethics Committee.
 - 22 d. Select committees.
 - 23 e. The Joint Legislative Ethics Committee or its Advisory
24 Subcommittee.

25 A bill authorized by this subdivision must be submitted to the Bill Drafting
26 Division of the Legislative Services Office no later than 4:00 P.M. Monday,
27 April 15, 2024, and must be filed for introduction in the Senate or introduced
28 in the House of Representatives no later than 4:00 P.M. Wednesday, May 1,
29 2024.
- 30 (5) Any local bill that has been submitted to the Bill Drafting Division of the
31 Legislative Services Office by 4:00 P.M. Monday, April 15, 2024, is
32 introduced in the House of Representatives or filed for introduction in the
33 Senate by 4:00 P.M. Tuesday, May 7, 2024.
- 34 (6) Bills providing for the selection, appointment, or confirmation as required by
35 law, including the filling of vacancies of positions for which the appointees
36 were elected by the General Assembly upon recommendation of the Speaker
37 of the House of Representatives, President of the Senate, or President Pro
38 Tempore of the Senate.
- 39 (7) Bills providing for action on gubernatorial nominations or appointments.
- 40 (8) Any matter authorized by joint resolution passed by a two-thirds majority of
41 the members of the House of Representatives present and voting and by a
42 two-thirds majority of the members of the Senate present and voting. A bill or
43 resolution filed in either house under the provisions of this subdivision shall
44 have a copy of the ratified enabling resolution attached to the jacket before
45 filing for introduction in the Senate or introduction in the House of
46 Representatives.

10 other elected officials' actions and any other litigation challenging the legality
11 of legislative enactments.

12 (14) Any bills relating to election laws, including bills concerning the districts for
13 Congressional, State House, State Senate, judicial, municipal, county, and
14 other elected officials.

15 (15) Bills to disapprove rules under G.S. 150B-21.3.

16 (16) Bills providing for impeachment pursuant to Article IV of the North Carolina
17 Constitution or Chapter 123 of the General Statutes.

18 (17) A joint resolution further adjourning the 2023 Regular Session, amending a
19 joint resolution adjourning the 2023 Regular Session, or adjourning the 2023
20 Regular Session, sine die.

21 **SECTION 8.** The Speaker of the House of Representatives or the President Pro
22 Tempore of the Senate may authorize appropriate committees or subcommittees of their
23 respective houses to meet during the interims between sessions to (i) review matters related to
24 the State budget for the 2023-2025 fiscal biennium, (ii) prepare reports, including revised
25 budgets, or (iii) consider any other matters as the Speaker of the House of Representatives or the
26 President Pro Tempore of the Senate deems appropriate. A conference committee may meet in
27 the interim upon approval by the Speaker of the House of Representatives or the President Pro
28 Tempore of the Senate.

29 **SECTION 9.** This resolution is effective upon ratification.
