



1 Commissioners, hereinafter at times referred to as the 'Board,' may provide for the  
2 exercise of all municipal powers, and shall be charged with the general government of  
3 the Town.

4 "Sec. 2.2. **Board of Commissioners; Composition; Terms of Office.** The Board  
5 shall be composed of five members, each of whom shall be elected for a term of four  
6 years in the manner provided by Article III of this Charter, provided they shall serve  
7 until their successors are elected and qualified.

8 "Sec. 2.3. **Mayor; Term of Office; Duties.** The Mayor shall be elected in the  
9 manner provided by Article III of this Charter to serve for a term of four years, or until  
10 his successor is elected and qualified. The Mayor shall be the official head of the Town  
11 government and shall preside at all meetings of the Board. He shall have the right to  
12 vote only when there are an equal number of votes in the affirmative and the negative  
13 on any motion before the Board. The Mayor shall exercise such powers and perform  
14 such duties as presently are or hereafter may be conferred upon him by the General  
15 Statutes of North Carolina, by this Charter, and by the ordinances of the Town.

16 "Sec. 2.4. **Mayor Pro Tempore.** In accordance with general law, the Board shall  
17 appoint one of its members to act as Mayor Pro Tempore to perform the duties of the  
18 mayor in the Mayor's absence or disability. The Mayor Pro Tempore shall have no fixed  
19 term of office, but shall serve in such capacity at the pleasure of the remaining members  
20 of the Board.

21 "Sec. 2.5. **Meetings of the Board.** In accordance with general law, the Board shall  
22 establish a suitable time and place for its regular meetings. Special meetings may be  
23 held as provided by general law.

24 "ARTICLE III. ELECTIONS.

25 "Sec. 3.1. **Regular Municipal Elections; Conduct and Method of Election.**  
26 Regular municipal elections shall be held in the Town every two years in odd-numbered  
27 years and shall be conducted in accordance with the uniform municipal election laws of  
28 North Carolina. Elections shall be conducted on a nonpartisan basis and the results  
29 determined by a plurality as provided in G.S. 163-292.

30 "Sec. 3.2. **Election of Commissioners.** The qualified voters of the entire Town shall  
31 elect the members of the Board. The candidates for the Board shall be elected at large.  
32 Those candidates who receive the highest number of votes in the Town at large shall be  
33 declared duly elected to the office for which the candidate has filed. At the municipal  
34 election to be held in November 2001, two members shall be elected for a four-year  
35 term and at the municipal election to be held in November 2003, three members shall be  
36 elected for a four-year term. Commissioners Charles M. Rooks and Howard N. Walker,  
37 Jr., shall continue to serve as members of the Board until the expiration of their terms in  
38 December 2001. Commissioners Charles M. Harrell, Charles E. Sparkman, and R.  
39 Eugene Brown shall continue to serve as members of the Board until the expiration of  
40 their terms in December 2003.

41 "Sec. 3.3. **Election of the Mayor.** At the regular municipal election in 2001, and  
42 quadrennially thereafter, a Mayor shall be elected to serve a term of four years. The

1 qualified voters of the entire Town shall elect the Mayor. John W. James, Jr. shall serve  
2 as Mayor until the expiration of his term in December 2001.

3 "ARTICLE IV. ORGANIZATION AND ADMINISTRATION.

4 "Sec. 4.1. **Form of Government.** The Town shall operate under the  
5 Council-Manager form of government as provided in Part 2 of Article 7 of Chapter  
6 160A of the General Statutes.

7 "Sec. 4.2. **Town Manager.** The Board shall appoint a Town Manager who shall be  
8 the administrative head of the Town government and shall be responsible for the  
9 administration of all departments of the Town government. The Town Manager shall be  
10 appointed with regard to merit only, and shall hold office at the pleasure of the Board  
11 and shall receive such compensation as the Board shall fix by ordinance.

12 The Town Manager shall also perform the following duties:

- 13 (1) Take measures to ensure that within the Town the laws of the State and  
14 the ordinances, resolutions, and regulations of the Board are faithfully  
15 executed.
- 16 (2) Attend all meetings of the Board and recommend for adoption any  
17 measures he deems expedient.
- 18 (3) Make reports to the Board from time to time upon affairs of the Town,  
19 and keep the Board fully advised of the Town's financial condition and  
20 its future financial needs.
- 21 (4) Appoint, suspend, and remove all heads of departments and other  
22 employees of the Town, except the Town Attorney and the Town  
23 Clerk, who shall be appointed by the Board.
- 24 (5) Perform any other duties that may be required and authorized by the  
25 Board.
- 26 (6) Prepare and submit the annual budget and capital program to the  
27 Board.

28 "ARTICLE V. SPECIAL PROVISIONS.

29 "Sec. 5.1. **Intent.** The purpose of this act is to revise the Charter of the Town of  
30 Burgaw and to consolidate herein certain acts concerning the property, affairs, and  
31 government of the Town. It is intended to continue without interruption those provisions  
32 of prior acts that are consolidated into this act so that all rights and liabilities that have  
33 accrued are preserved and may be enforced.

34 "Sec. 5.2. **Construction.** This act shall not be deemed to repeal, modify, or in any  
35 manner affect any of the following acts, portions of acts, or amendments thereto,  
36 whether or not the acts, portions of acts, or amendments are expressly set forth herein:

- 37 (1) Any acts concerning the property, affairs, or government of public  
38 schools in the Town of Burgaw.
- 39 (2) Any acts validating, confirming, approving, or legalizing official  
40 proceedings, actions, contracts, or obligations of any kind.

1 "Sec. 5.3. **Repeal of Specific Acts.** The following acts or portions of acts, having  
2 served the purposes for which they were enacted, or having been consolidated into this  
3 act are hereby repealed:

16 "Sec. 5.4. **Exclusions.** No provision of this act is intended, nor shall be construed, to  
17 affect in any way any rights or interests, whether public or private:

18 (1) Now vested or accrued, in whole or in part, the validating of which  
19 might be sustained or preserved by reference to any provisions of law  
20 repealed by this act.

21 (2) Derived from, or which might be sustained or preserved in reliance  
22 upon, action heretofore taken pursuant to or within the scope of any  
23 provisions of law repealed by this act.

24 "Sec. 5.5. **Revival.** No law heretofore repealed expressly or by implication, and no  
25 law granting authority which has been exhausted, shall be revived by either:

26 (1) The repeal herein of any act repealing such law.

27 (2) Any provision of this act that disclaims an intention to repeal or affect  
28 enumerated or designated laws.

29 "Sec. 5.6. **Prior Ordinances Saved.** All existing ordinances and resolutions of the  
30 Town of Burgaw and all existing rules or regulations of departments or agencies of the  
31 Town of Burgaw, not inconsistent with the provisions of this act, shall continue in full  
32 force and effect until repealed, modified, or amended.

33 "Sec. 5.7. **Effect on Legal Proceedings.** No action or proceeding of any nature,  
34 whether civil or criminal, judicial or administrative, or otherwise, pending on the  
35 effective date of this act by or against the Town of Burgaw or any of its departments or  
36 agencies shall be abated or otherwise affected by the adoption of this act.

37 "Sec. 5.8. **Severability.** If any provision of this act or the application thereof to any  
38 person or circumstance is held invalid, the invalidity shall not affect other provisions or  
39 applications of this act which can be given effect without the invalid provision or  
40 application, and to this end the provisions of this act are declared to be severable.

41 "Sec. 5.9. **Reference to Amended Provisions.** Whenever a reference is made in this  
42 act to a particular provision of the General Statutes, and the provision is later amended,

1 repealed, recodified, or superseded, the reference shall be deemed amended to refer to  
2 the amended General Statutes, or to the General Statutes which most clearly correspond  
3 to the statutory provision that is amended, repealed, recodified, or superseded.

4 "Sec. 5.10. **General Repealer.** All laws and clauses of laws in conflict with the  
5 provisions of this act are hereby repealed."

6 **SECTION 2.** This act is effective when it becomes law.
