1 A BILL TO BE ENTITLED
2 AN ACT TO PROVIDE SOME BUDGET FLEXIBILITY TO THE NORTH
3 CAROLINA SCHOOL OF SCIENCE AND MATHEMATICS.

4 The General Assembly of North Carolina enacts:

5 SECTION 1. G.S. 116-30.2 reads as rewritten:

6 "§ 116-30.2. Appropriations to special responsibility constituent
7 ~~institutions.~~institutions and to the North Carolina School of Science and
8 Mathematics.

9 (a) All General Fund appropriations made by the General Assembly for
10 continuing operations of a special responsibility constituent institution of The
11 University of North Carolina shall be made in the form of a single sum to each budget
12 code of the institution for each year of the fiscal period for which the appropriations are
13 being made. Notwithstanding G.S. 143-23(a1), G.S. 143-23(a2), and G.S. 143-23(a3)
14 and G.S. 120-76(8), each special responsibility constituent institution may expend
15 monies from the overhead receipts special fund budget code and the General Fund
16 monies so appropriated to it in the manner deemed by the Chancellor to be calculated to
17 maintain and advance the programs and services of the institutions, consistent with the
18 directives and policies of the Board of Governors. The preparation, presentation, and
19 review of General Fund budget requests of special responsibility constituent institutions
20 shall be conducted in the same manner as are requests of other constituent institutions.
21 The quarterly allotment procedure established pursuant to G.S. 143-17 shall apply to the
22 General Fund appropriations made for the current operations of each special
23 responsibility constituent institution. All General Fund monies so appropriated to each
24 special responsibility constituent institution shall be recorded, reported, and audited in
25 the same manner as are General Fund appropriations to other constituent institutions.

26 (b) All General Fund appropriations made by the General Assembly for
27 continuing operations of the North Carolina School of Science and Mathematics shall be
28 made in the form of a single sum to each budget code of the School for each year of the

1 fiscal period for which the appropriations are being made. Notwithstanding G.S. 143-
2 23(a1), 143-23(a2), 143-23(a3), and G.S. 120-76(8), the North Carolina School of
3 Science and Mathematics may expend monies from the overhead receipts special fund
4 budget code and the General Fund monies so appropriated to it in the manner deemed
5 by the Director of the School to be calculated to maintain and advance the programs and
6 services of the School, consistent with the directives and policies of the Board of
7 Trustees of the North Carolina School of Science and Mathematics. The preparation,
8 presentation, and review of General Fund budget requests of special responsibility
9 constituent institutions shall be conducted in the same manner as are requests of the
10 constituent institutions. The quarterly allotment procedure established pursuant to G.S.
11 143-17 shall apply to the General Fund appropriations made for the current operations
12 of the North Carolina School of Science and Mathematics. All General Fund monies so
13 appropriated to the North Carolina School of Science and Mathematics shall be
14 recorded, reported, and audited in the same manner as are General Fund appropriations
15 to constituent institutions of The University of North Carolina."

16 **SECTION 2.** This act becomes effective July 1, 2001.
