2 AN ACT TO APPROPRIATE FUNDS TO ESTABLISH THREE ADDITIONAL  
3 ASSISTANT DISTRICT ATTORNEY POSITIONS FOR DISTRICT 19A.

4 The General Assembly of North Carolina enacts:

5           **SECTION 1.** G.S. 7A-60(a1) reads as rewritten:

6           "(a1) The counties of the State are organized into prosecutorial districts, and each  
7 district has the counties and the number of full-time assistant district attorneys set forth  
8 in the following table:

36           **SECTION 2.** There is appropriated from the General Fund to the Judicial  
37 Department the sum of two hundred fifty-four thousand eighty-eight dollars (\$254,088)  
38 for the 2006-2007 fiscal year to establish the three additional assistant district attorney  
39 positions authorized by this act.

40           **SECTION 3.** This act becomes effective July 1, 2006.
