A BILL TO BE ENTITLED

AN ACT TO ESTABLISH THE WATERFRONT ACCESS STUDY COMMITTEE AND TO DIRECT THE COMMITTEE TO STUDY THE LOSS OF DIVERSITY OF USES ALONG THE COASTAL SHORELINE OF NORTH CAROLINA AND HOW THESE LOSSES IMPACT ACCESS TO THE PUBLIC TRUST WATERS OF THE STATE, AS RECOMMENDED BY THE JOINT LEGISLATIVE COMMISSION ON SEAFOOD AND AQUACULTURE.

Whereas, there is a growing concern that the State may be experiencing a loss of diversity of uses along its coastal shoreline as more people seek waterfront property; and

Whereas, many of the State's waterfront uses such as public marinas, boat building and boat servicing companies, commercial fishing facilities, fish houses, and other commercial establishments that depend on water access are being replaced by residential properties; and

Whereas, the North Carolina Marine Fisheries Commission and the North Carolina Coastal Resources Commission have adopted resolutions recognizing the importance of waterfront access issues; Now, therefore,

The General Assembly of North Carolina enacts:

**SECTION 1.** Committee Created. – There is created the Waterfront Access Study Committee.

**SECTION 2.** Membership. – The Committee shall be comprised of 17 members as follows:

- (1) The Director of the Sea Grant College Program of The University of North Carolina or the Director's designee.
- (2) The Senate Cochair of the Joint Legislative Commission on Seafood and Aquaculture or the Cochair's designee.
- (3) The House Cochair of the Joint Legislative Commission on Seafood and Aquaculture or the Cochair's designee.
- (4) The Chair of the Marine Fisheries Commission or the Chair's designee.

Specifically, the Committee shall: 36 37 Gather information about local land-use management and zoning, (1) 38 current shoreline development trends, and local tax rates, including tax 39 assessment trends for shoreline properties. Collect research and information from North Carolina and other states 40 (2) regarding 41 iurisdictions incentive-based techniques and

- (4) Prepare a draft report with a statement of the issues, a summary of the research, and recommendations to address issues of diversity of waterfront use and access in North Carolina.
- (5) Hold three public meetings to present the draft report and recommendations to the public and user groups. One public meeting shall be held in each of the three coastal regions described by G.S. 143B-289.54(b).

**SECTION 4.** Vacancies. – Any vacancy shall be filled by the original appointing authority.

**SECTION 5.** Quorum. – A quorum of the Committee shall be a majority of its members.

 **SECTION 6.** Chair. – The Director of the Sea Grant College Program of The University of North Carolina or the Director's designee shall be the Chair of the Committee.

**SECTION 7.** Meetings. – The Committee shall meet upon the call of the Chair.

 **SECTION 8.** Expenses of Members. – Members of the Committee shall receive per diem, subsistence, and travel allowances in accordance with G.S. 120-3.1, 138-5, or 138-6, as appropriate.

**SECTION 9.** Report. – The Committee may submit an interim report of its study to the Joint Legislative Commission on Seafood and Aquaculture, the Marine Fisheries Commission, and the Coastal Resources Commission no later than November 1, 2006. The Committee shall submit a final report of the results of its study, including any legislative recommendations, to the Joint Legislative Commission on Seafood and Aquaculture, the Marine Fisheries Commission, and the Coastal Resources Commission no later than January 15, 2007.

**SECTION 10.** Expiration of Committee. – The Committee shall terminate on January 31, 2007, or upon the filing of its final report, whichever occurs first.

**SECTION 11.** Funds. – There is appropriated from the General Fund to the Sea Grant College Program of The University of North Carolina the sum of fifty thousand dollars (\$50,000) for the 2006-2007 fiscal year for the costs of the Waterfront Access Study Committee created by this act.

**SECTION 12.** This act becomes effective July 1, 2006.
