A BILL TO BE ENTITLED 1 2 AN ACT TO APPROPRIATE FUNDS TO THE BOARD OF GOVERNORS OF THE UNIVERSITY OF NORTH CAROLINA TO EXPAND NURSING AND HEALTH 3 4 CARE. 5 The General Assembly of North Carolina enacts: **SECTION 1.** There is appropriated from the General Fund to the Board of 6 7 Governors of The University of North Carolina the sum of forty-three thousand dollars 8 (\$43,000) for the 2006-2007 fiscal year to fund temporary space for the Elizabeth City 9 State University Pharmacy Program. **SECTION 2.** There is appropriated from the General Fund to the Board of 10 Governors of The University of North Carolina the sum of two million five hundred 11 thousand dollars (\$2,500,000) for the 2006-2007 fiscal year to fund indigent care 12 reimbursement for East Carolina University Brody School of Medicine. This funding 13 14 will partially compensate the School for the cost of providing significant levels of service to uninsured patients. 15 16 **SECTION 3.** There is appropriated from the General Fund to the Board of Governors of The University of North Carolina the sum of five million three hundred 17 18 thirty-one thousand five hundred six dollars (\$5,331,506) for the 2006-2007 fiscal year 19 to be allocated as follows: 20 \$3,731,506 to fund Area Health Education Centers (AHEC) (1)21 Expansion. \$1.000.000 to fund the establishment of a new Area Health Education 22 (2)Center (AHEC) in Elizabeth City. 23 \$600,000 to fund an expansion of Area Health Education Centers 24 (3) (AHEC) to improve and expand nursing clinical education. 25 SECTION 4. There is appropriated from the General Fund to the Board of 26 Governors of The University of North Carolina the sum of two million five hundred 27

Commission shall give priority to full-time students over part-time students. The State
Education Assistance Authority shall adopt specific rules to regulate scholarship loans
to part-time master of science in nursing students and part time baccalaureate degree
students.students.

5 Within current funds available or with any additional funds provided by the General 6 Assembly for this purpose, the Commission may set aside slots for scholarship loans 7 prescribed by subdivisions (1) and (2) subdivision (1) of this subsection to enable 8 licensed practical nurses to become registered nurses. The State Education Assistance 9 Authority shall adopt specific rules to regulate these scholarship loans.

10 If a recipient is awarded a scholarship loan under this program and is (b1) enrolled, or accepted for enrollment, in a baccalaureate nursing program, but is unable 11 12 to pursue the course of study in nursing for a semester due to limited faculty resources 13 at the institution for that semester, then the recipient shall continue to receive the 14 scholarship loan for that semester and shall not be required to forfeit or repay the 15 scholarship loan for that semester provided that the recipient remains otherwise eligible 16 for the program. This waiver shall be valid for only one semester of study and may 17 extend a recipient's eligibility for funding under the program by no more than one 18 semester.

19 (c) The Commission shall adopt stringent standards, which may include 20 minimum grade point average, scholastic aptitude test scores, and other standards 21 deemed appropriate by the Commission, to ensure that only the best potential students 22 receive and retain loans under the Nursing Scholars Program. Standards adopted by the 23 Commission shall include provisions for ensuring that the qualifications of applicants 24 who are or would be nontraditional students are considered fairly in providing them 25 with opportunities to compete for the loans. Loans under the Nursing Scholars Program shall be awarded only to applicants who meet the standards set by the Commission and 26 27 who agree to practice nursing in North Carolina upon completion of the nursing education program supported by the loan. 28

(d) The Commission shall develop and administer the Nursing Scholars Program in cooperation with nursing schools at institutions approved by the Commission and the North Carolina Board of Nursing. The Nursing Scholars Program shall provide for participants to be exposed to a range of extracurricular activities while in school, which activities shall be aimed at instilling in students a strong motivation to remain in the practice of nursing and to provide leadership for the nursing profession.

35 (e) The Commission may form regional review committees <u>within North</u> 36 <u>Carolina</u> to assist it in identifying the best high school seniors and other applicants for 37 the program. The Commission and the review committees shall make an effort to 38 identify and encourage minority students and students who may not otherwise consider 39 a career in nursing to apply for the Nursing Scholars Program.

40 (f) Upon the naming of recipients of loans from the Nursing Scholars Program, 41 the Commission shall inform the State Education Assistance Authority (SEAA) of its 42 decisions. The SEAA shall perform all of the administrative functions necessary to 43 implement this Article, which functions shall include: rule-making, dissemination of 44 information to the public, distribution and receipt of applications for scholarship loans, and the functions necessary for the execution, payment, and enforcement of promissory
notes required under this Article."

**SECTION 6.(b)** There is appropriated from the General Fund to the Board of Governors of The University of North Carolina the sum of two million seven hundred fifty thousand dollars (\$2,750,000) for the 2006-2007 fiscal year to fund an expansion of the Nursing Scholars Program. This funding will increase awards for the Nursing Scholars Program from five thousand dollars (\$5,000) to six thousand five hundred dollars (\$6,500) per year, to begin to include masters degree students and to increase the current number of awards.

10 **SECTION 7.** There is appropriated from the General Fund to the Board of 11 Governors of The University of North Carolina the sum of one million two hundred 12 thousand dollars (\$1,200,000) for the 2006-2007 fiscal year to fund the Graduate Nurse 13 Scholarship Program. This program would fund up to two years of study for a masters 14 degree student and up to three years of study for a doctoral degree student.

15 **SECTION 8.** There is appropriated from the General Fund to the Board of 16 Governors of The University of North Carolina the sum of three million six hundred 17 fourteen thousand three hundred sixty-five dollars (\$3,614,365) for the 2006-2007 fiscal 18 year to fund the clinical component of nursing and to hire more clinical faculty.

**SECTION 9.** There is appropriated from the General Fund to the Board of Governors of The University of North Carolina the sum of eight hundred fifty thousand dollars (\$850,000) for the 2006-2007 fiscal year to fund new Bachelor of Science in Nursing programs at Fayetteville State University and the University of North Carolina at Pembroke and a new Registered Nurse to Bachelor of Science in Nursing program at Appalachian State University.

SECTION 10. This act becomes effective July 1, 2006. Subsection (a) of
Section 6 of this act shall apply to all scholarship loans awarded or renewed on or after
that date.
