2 AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO PRODUCE
3 A SPECIAL PLATE FOR THE PRESIDENT OF THE NORTH CAROLINA
4 COMMUNITY COLLEGES SYSTEM.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** G.S. 20-79.5(a) reads as rewritten:

7 "**§ 20-79.5. (Effective July 1, 2007) Special registration plates for elected and**
8 **appointed State government officials.**

9 (a) Plates. – The State government officials listed in this section are eligible for a
10 special registration plate under G.S. 20-79.4. The plate shall bear the number designated
11 in the following table for the position held by the official.
