1	A BILL TO BE ENTITLED
2	AN ACT TO PROVIDE LEGISLATORS WITH THE SAME MILEAGE RATES AS
3	STATE EMPLOYEES AND TO ESTABLISH BOTH STATE EMPLOYEE AND
4	LEGISLATIVE RATES AT THE FEDERAL EMPLOYEE RATE FOR TRAVEL.
5	The General Assembly of North Carolina enacts:
6	<b>SECTION 1.</b> G.S. 138-6(a)(1) reads as rewritten:
7	"(a) Travel on official business by the officers and employees of State
8	departments, institutions and agencies which operate from funds deposited with the
9	State Treasurer shall be reimbursed at the following rates:
10	(1) For transportation by privately owned automobile, the business
11	standard mileage rate set by the Internal Revenue Service per mile of
12	travel and the actual cost of tolls paid. An agency may require that an
13	employee use a State-provided vehicle and, if one is available but
14	declined, may pay a lower rate. Any other law which sets a mileage
15	rate by referring to the rate set herein, instead establishes a rate of
16	twenty-five cents (25¢) per mile. No reimbursement shall be made for
17	the use of a personal car in commuting from an employee's home to
18	his duty station in connection with regularly scheduled work hours.
19	Any designation of an employee's home as his duty station by a
20	department head shall require prior approval by the Office of State
21	Budget and Management on an annual basis.

23	<b>SECTION 2.</b> G.S. 120-3.1(a)(1) and (2) read as rewritten:
24	"(a) In addition to compensation for their services, members of the General
25	Assembly shall be paid the following allowances:
26	(1) A weekly travel allowance for each week or fraction thereof that the
27	General Assembly is in regular or extra session. The amount of the
28	weekly travel allowance shall be calculated for each member by
29	multiplying the actual round-trip mileage from that member's home to

12	2007. Section 2 of this act becomes effective upon convening of the 2009 Regular
13	Session of the General Assembly.
