2	AN ACT TO AMEND THE REQUIREMENTS FOR CERTAIN ABC PERMIT
3	HOLDERS TO RECYCLE RECYCLABLE CONTAINERS, AND TO PROVIDE
4	THAT A FAILURE OF A PERMIT HOLDER TO RECYCLE AS REQUIRED IS
5	A VIOLATION PUNISHABLE UNDER G.S. 130A-22.
6	The General Assembly of North Carolina enacts:
7	SECTION 1. G.S. 18B-1006.1 reads as rewritten:
8	"§ 18B-1006.1. (Effective January 1, 2008) Additional requirement for certain
9	permittees to recycle beverage containers.
10	(a) Holders of on-premises malt beverage permits, on-premises unfortified wine
11	permits, on-premises fortified wine permits, and mixed beverages permits shall
12	separate, store, and provide for the collection for recycling of all recyclable beverage
13	containers of all beverages sold at retail on the premises. A permittee has satisfied the
14	requirements of this subsection if it implements a recycling program that meets the
15	minimum standards of the model recycling program developed by the Commission
16	pursuant to G.S. 130A-309.14(m). For purposes of this section, "recyclable beverage
17	containers" shall not include glass malt beverage containers.
18	(b) The requirements of subsection (a) of this section do not apply to permittees
19	for premises that are located in areas where the local government having jurisdiction
20	does not provide for the collection of recyclable materials from business establishments.
21	(c) Failure of a permittee to separate, store, and provide for the collection for
22	recycling of all recyclable beverage containers of all beverages sold at retail on the
23	premises as required by this section shall constitute a violation punishable as provided
24	<u>in G.S. 130A-22(j).</u> "
25	SECTION 2. G.S. 130A-22 is amended by adding a new subsection to read:
26	"(j) The Secretary may impose an administrative penalty on a holder of an
27	on-premises malt beverage permit, on-premises unfortified wine permit, on-premises
28	fortified wine permit, and mixed beverages permit for the failure of the permittee to
29	separate, store, and provide for the collection for recycling of all recyclable beverage

- 1 containers of all beverages sold at retail on the premises as required by
- 2 G.S. 18B-1006.1. Each day of a continuing violation is a separate violation. The penalty
- 3 shall not exceed one thousand dollars (\$1,000) for each day the violation continues."
- 4 **SECTION 3.** This act is effective when it becomes law.
