SECTION 2. There is appropriated from the General Fund to the Judicial Department the sum of one million four hundred eighty-three thousand thirty-five dollars (\$1,483,035) for the 2007-2008 fiscal year and the sum of one million four hundred thirty-three thousand nine hundred seventy dollars (\$1,433,970) for the 2008-2009 fiscal year to establish the 15 additional assistant district attorneys authorized by this act.
