1 A BILL TO BE ENTITLED

- 2 AN ACT TO PROVIDE A SMALL BUSINESS INCOME TAX EXEMPTION.
- 3 The General Assembly of North Carolina enacts:

**SECTION 1.** G.S. 105-130.3 reads as rewritten:

"§ 105-130.3. Corporations.

Tax. – A tax is imposed on the State net income of every C Corporation doing business in this State. An S Corporation is not subject to the tax levied in this section.

The tax is a percentage of the taxpayer's State net income computed as follows:

| 9  | Income Years Beginning | Tax   |
|----|------------------------|-------|
| 10 | In 1997                | 7.5%  |
| 11 | In 1998                | 7.25% |
| 12 | In 1999                | 7%    |
| 13 | After 1999             | 6.9%. |

Exemption. – Before computing the tax in subsection (a) of this section, a C (b) Corporation that is not required to apportion income to this State may subtract from State net income fifty thousand dollars (\$50,000). If a C Corporation is required to apportion income to this State, the applicable exemption amount is the product of the corporation's apportionment fraction determined under G.S. 105-130.4(i) multiplied by fifty thousand dollars (\$50,000)."

**SECTION 2.** G.S. 115C-546.1(b) reads as rewritten:

Each calendar quarter, the Secretary of Revenue shall remit to the State Treasurer for credit to the Public School Building Capital Fund an amount equal to the applicable fraction or percentage provided in the table below of the net collections received during the previous quarter by the Department of Revenue under G.S. 105-130.3. All funds deposited in the Public School Building Capital Fund shall be invested as provided in G.S. 147-69.2 and G.S. 147-69.3.
