5	The General Assembly of North Carolina enacts:
6	SECTION 1. G.S. 77-98 reads as rewritten:
7	"§ 77-98. Annual report.
8	The Commission shall submit an annual report, including any recommendations, on
9	or before 1 October of each year to the Governor of North Carolina, the Environmental
10	Review Commission of the General Assembly of North Carolina, the Governor of
11	Virginia, and the General Assembly of Virginia."
12	SECTION 2. G.S. 106-744 reads as rewritten:
13	"§ 106-744. Purchase of agricultural conservation easements; establishment of
14	North Carolina Agricultural Development and Farmland Preservaton
15	Preservation Trust Fund and Advisory Committee.
16	
17	(i) The Advisory Committee shall report no later than May 1 of each year to the
18	Joint Legislative Commission on Governmental Operations, the Environmental Review
19	Commission, and the House of Representatives and Senate Appropriations
20	Subcommittees on Natural and Economic Resources regarding the activities of the
21	Advisory Committee, the agriculture easements purchased, and agricultural projects
22	funded during the previous year.

24	SECTION 3. G.S. 130A-294.1 reads as rewritten:
25	"§ 130A-294.1. Fees applicable to generators and transporters of hazardous waste,
26	and to hazardous waste storage, treatment, and disposal facilities.

General Assembly of North Carolina

1 (a) It is the intent of the General Assembly that the fee system established by this 2 section is solely to provide funding in addition to federal and State appropriations to 3 support the State's hazardous waste management program.

5 (p) The Department shall make an annual report on or before 1 October to the 6 General Assembly and its Fiscal Research Division on the cost of the hazardous waste 7 management program. The report shall include, but is not limited to, beginning fund 8 balance, fees collected under this section, anticipated revenue from all sources, total 9 expenditures (byby activities and categories) categories for the hazardous waste 10 management program, ending fund balance, any recommended adjustments in the 11 annual and tonnage fees which may be necessary to assure the continued availability of 12 funds sufficient to pay the State's share of the cost of the hazardous waste management 13 program, and any other information requested by the General Assembly. In 14 recommending adjustments in annual and tonnage fees, the Department may propose 15 fees for hazardous waste generators, and for hazardous waste treatment facilities which 16 treat waste generated on-site, which are designed to encourage reductions in the volume 17 or quantity and toxicity of hazardous waste."
