The General Assembly of North Carolina enacts: **SECTION 1.** G.S. 105-275 is amended by adding a new subdivision to read: "§ 105-275. Property classified and excluded from the tax base. The following classes of property are hereby designated special classes under authority of Article V, Sec. 2(2), of the North Carolina Constitution and shall not be listed, appraised, assessed, or taxed: (5b)The first two thousand dollars (\$2,000) of the appraised value of one motor vehicle owned by an individual who is at least 65 years of age and who has an income of not more than the income eligibility limit specified in G.S. 105-277.1.
