1 A JOINT RESOLUTION HONORING THE FALLEN SOLDIERS WHO SERVED OUR
2 NATION IN OPERATIONS IRAQI FREEDOM AND ENDURING FREEDOM.

3 Whereas, Memorial Day, originally known as Decoration Day, began on May 30,
4 1868, when General John A. Logan declared the day an occasion to decorate the graves of Civil
5 War soldiers; and

6 Whereas, by the early 1900s, several states had declared Decoration Day as an
7 official holiday; and

8 Whereas, after World War I, Decoration Day was expanded to honor service
9 members killed in all of the nation's wars and, after World War II, Decoration Day became
10 known as Memorial Day; and

11 Whereas, in 1971, Congress established Memorial Day as a federal holiday to be
12 observed on the last Monday of May; and

13 Whereas, as we observe Memorial Day in 2009, it is fitting to honor and express
14 profound gratitude to the North Carolinians who were killed in the line of duty during
15 Operations Iraqi Freedom and Enduring Freedom in Iraq and Afghanistan; and

16 Whereas, these courageous individuals should be remembered and honored for their
17 valiant and heroic efforts in protecting the national security interest of the United States and
18 upholding the principles of democracy and freedom; Now, therefore,
19 Be it resolved by the House of Representatives, the Senate concurring:

20 **SECTION 1.** The General Assembly expresses its profound gratitude and
21 appreciation to all the men and women of the United States Armed Forces for their selfless
22 service.
