A BILL TO BE ENTITLED

AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE
RECOMMENDATION OF THE SPEAKER OF THE HOUSE OF REPRESENTATIVES.

Whereas, G.S. 120-121 authorizes the General Assembly to make certain appointments to public offices upon the recommendation of the Speaker of the House of Representatives; and

Whereas, the Speaker of the House of Representatives has made recommendations;

Now, therefore,

The General Assembly of North Carolina enacts:

SECTION 1.1. Nancy W. Davison of Wake County is appointed to the Acupuncture Licensing Board for a term expiring on June 30, 2013.

SECTION 1.2.(a) Effective October 1, 2010, E.B. Palmer of Wake County is appointed to the African-American Heritage Commission for a term expiring on September 30, 2013.

SECTION 1.2.(b) Bernard George of Craven County is appointed to the African-American Heritage Commission for a term expiring on September 30, 2012, to fill the unexpired term of Donald A. Bonner.
