Short Title: Prohibit Sale of Novelty Lighters.

1 A BILL TO BE ENTITLED
2 AN ACT TO PROHIBIT THE RETAIL SALE AND DISTRIBUTION OF NOVELTY
3 LIGHTERS, AS RECOMMENDED BY THE CHILD FATALITY TASK FORCE.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** The title of Article 2 of Chapter 66 of the General Statutes reads as
6 rewritten:

7 "Article 2.

8 Manufacture and Sale of ~~Matches~~ Matches and Lighters."

9 **SECTION 2.** G.S. 66-16 reads as rewritten:

10 **"§ 66-16. Violation of Article a misdemeanor.**

11 Any person, association, or corporation violating any of the provisions of this ~~Article~~
12 Article, other than G.S. 66-16.1, shall be guilty of a Class 3 misdemeanor and shall only be
13 fined for the first offense not less than five dollars (\$5.00) nor more than twenty-five dollars
14 (\$25.00), and for each subsequent violation not less than twenty-five dollars (\$25.00)."

15 **SECTION 3.** Article 2 of Chapter 66 of the General Statutes is amended by adding
16 a new section to read:

17 **"§ 66-16.1. Retail sale of novelty lighters prohibited.**

18 (a) Definition. – As used in this section, the term 'novelty lighter' means a mechanical
19 or electrical device typically used for lighting cigarettes, cigars, or pipes, that is designed to
20 resemble a cartoon character, toy, gun, watch, musical instrument, vehicle, animal, food or
21 beverage, or similar articles, or that plays musical notes. A novelty lighter may operate on any
22 fuel, including butane, isobutene, or liquid fuel.

23 (b) Prohibition. – It shall be unlawful to sell at retail, offer to sell at retail, or give, or
24 distribute for retail sale or promotion, a novelty lighter in this State. This prohibition does not
25 apply to the transportation of novelty lighters through this State or to the storage of novelty
26 lighters in a warehouse or distribution center in this State that is closed to the public for
27 purposes of retail sales.

28 (c) Exceptions. – The prohibition in this section does not apply to any of the following:

29 (1) A lighter manufactured prior to January 1, 1980.

30 (2) Any mechanical or electrical device primarily used to ignite fuel for
31 fireplaces or charcoal or gas grills.

32 (3) Standard disposable or refillable lighters that are printed or decorated with
33 logos, labels, decals or artwork, or heat shrinkable sleeves, but which do not
34 otherwise resemble a novelty lighter.

35 (d) Civil Penalty. – Any person who violates the prohibition in subsection (b) of this
36 section shall be subject to a civil penalty of five hundred dollars (\$500.00) for each violation. A
37 civil penalty owed under this section may be imposed in a civil action brought by the Attorney



1 General or the district attorney of the appropriate prosecutorial district as defined in
2 G.S. 7A-60. The clear proceeds of any civil penalties imposed in any action initiated under this
3 section shall be remitted to the Civil Penalty and Forfeiture Fund in accordance with
4 G.S. 115C-457.2."

5 **SECTION 4.** This act becomes effective October 1, 2009, and applies to products
6 purchased on or after that date.
