3 INADVERTENTLY UNASSIGNED AREAS BY SESSION LAW 2011-203, AN ACT TO
4 REALIGN THE DISTRICTS FOR WAKE COUNTY SUPERIOR COURT JUDGE
5 SEATS TO PROVIDE FOR SINGLE MEMBER DISTRICTS AND EQUAL
6 REPRESENTATION IN THOSE DISTRICTS, AND TO CLARIFY THE TEXTUAL
7 EXPLANATION OF THE PLAN FOR WAKE COUNTY SUPERIOR COURT JUDGES.
