

3	The Administrative Officer of the Courts shall develop a process through which all other		
4	persons or entities may obtain copies of the appellate division reports by purchase. The		
5	purchase price shall represent the actual cost to the State of publication and shipping.		
6	Each justice of the Supreme Court and judge of the Court of Appeals shall receive for		
7	private use, one complete and up-to-date set of the appellate division reports. The copies of		
8	reports furnished each justice or judge as set out in the table above may be retained personally		
9	to enable the justice or judge to keep up-to-date the personal set of reports.		
10	(b) The appellate division reports shall be made available by electronic means, at no		
11	cost to the recipient, through publication in a downloadable format on a publicly available Web		
12	site."		
13	SECTION 2. This act is effective when it becomes law.
