Short Title: I.B.P.O.E.W. Special Plate. (Public)

1 A BILL TO BE ENTITLED  
2 AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO PRODUCE A  
3 SPECIAL REGISTRATION PLATE FOR THE IMPROVED BENEVOLENT AND  
4 PROTECTIVE ORDER OF ELKS OF THE WORLD (I.B.P.O.E.W.).

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** G.S. 20-79.4(b) is amended by adding a new subdivision to read:

7 "(b) Types. – The Division shall issue the following types of special registration plates:

8 ...

9 () I.B.P.O.E.W. – Issuable to the registered owner of a motor vehicle in  
10 accordance with G.S. 20-81.12. The plate shall bear the phrase "The  
11 Improved Benevolent and Protective Order of Elks of the World" and the  
12 logo of the Improved Benevolent and Protective Order of Elks of the World.

13 ...."

14 **SECTION 2.** G.S. 20-79.7(a) reads as rewritten:

15 "§ 20-79.7. Fees for special registration plates and distribution of the fees.

16 (a) Fees. – Upon request, the Division shall provide and issue free of charge a single  
17 Legion of Valor, 100% Disabled Veteran, and Ex-Prisoner of War registration plate to a  
18 recipient of a Legion of Valor award, a 100% disabled veteran, and an ex-prisoner of war each  
19 year. The preceding special registration plates are subject to the regular motor vehicle  
20 registration fees in G.S. 20-88, if the registered weight of the vehicle is greater than 6,000  
21 pounds. All other special registration plates are subject to the regular motor vehicle registration  
22 fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

29 **SECTION 3.** G.S. 20-79.7(b) reads as rewritten:

30 "(b) Distribution of Fees. – The Special Registration Plate Account and the Collegiate  
31 and Cultural Attraction Plate Account are established within the Highway Fund. The Division  
32 must credit the additional fee imposed for the special registration plates listed in subsection (a)  
33 of this section among the Special Registration Plate Account (SRPA), the Collegiate and  
34 Cultural Attraction Plate Account (CCAPA), the Natural Heritage Trust Fund (NHTF), which  
35 is established under G.S. 113-77.7, and the Parks and Recreation Trust Fund, which is  
36 established under G.S. 113-44.15, as follows:

**SECTION 4.** G.S. 20-81.12 is amended by adding a new subsection to read:

"(b126) I.B.P.O.E.W. – The Division must receive 300 or more applications for an I.B.P.O.E.W. plate before the plate may be developed. The Division shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the sale of I.B.P.O.E.W. plates to the North Carolina Alliance of Boys and Girls Clubs to support its mission of promoting the social welfare of boys and girls as served by various Boys and Girls Clubs in North Carolina that are affiliated with the Boys and Girls Clubs of America."

**SECTION 5.** This act becomes effective July 1, 2013.
