A BILL TO BE ENTITLED AN ACT AMENDING THE CHARTER OF THE CITY OF FAYETTEVILLE TO M CHANGES RELATED TO THE MEMBERSHIP AND OPERATION OF THE PU WORKS COMMISSION. The General Assembly of North Carolina enacts:	
SECTION 1. Chapter VI of the Charter of the City of Fayetteville, being C 557 of the 1979 Session Laws, as amended by Chapter 756 of the 1981 Session Law 1998-61, and S.L. 2008-103, is repealed.	
SECTION 2. The Charter of the City of Fayetteville, being Chapter 557 1979 Session Laws, as amended, is amended by adding a new Chapter to read as follows: "Chapter VIA. Public Works Commission.	
"§ 6A.1. Commission continued; election and term of members; vacancy. Commission of the City of Fayetteville to be known as the "Fayetteville Public Commission" (hereinafter "Commission") as heretofore created, established, and now ex is hereby continued and the number of members shall increase, effective October 1, 20	Works kisting,

The terms of office of each member shall be four years, and the terms shall expire years from the date on which the appointment was originally made, provided that a member shall continue to serve until a successor is appointed. A new appointment shall be me September of 2015, and it shall be for a term of four years. As each appointment expire	re four nember nade in res, the

If it is 4 determined that a member of the Commission is no longer a resident of the City, that seat shall 5 immediately become vacant, and a successor shall be appointed in accordance with Section 6 6.A1(b) of this Chapter. 7 "§ 6A.3. Organization; chair, vice-chair, secretary, and treasurer. The members of the 8 Commission shall meet as soon after their appointment as possible and shall elect out of their 9 number a chair, vice-chair, secretary, and treasurer, each of whom shall be a different person. 10 The duties of each shall be as prescribed by the Commission from time to time but shall not be 11 inconsistent with the provisions of this Chapter. Each voting member of the Commission shall give bond to the City in the following amounts: the sum of fifty thousand dollars 15 16 (\$50,000) in the case of the treasurer and twenty-five thousand dollars (\$25,000) for all other 17 members. All bonds required by this section shall be filed with the City Clerk. The provisions of Article 72 of Chapter 58 of the General Statutes shall apply to bonds given under this 18 19 section. 20 "§ 6A.5. Compensation. The members of the Commission shall receive a salary as set by 21 the City Council on an annual basis. Beginning July 1, 2016, using 2015 as a base, the salary 22 set by the City Council shall be adjusted annually by the rate of change in the Consumer Price 23 Index as reported by the Bureau of Labor Statistics of the United States Department of Labor. 24 "§ 6A.6. Neglect of duty by member. A member of the Commission may be removed from 25 office by a two-thirds vote of the City Council if the member: 26 (1)Willfully neglects or fails to perform any duty required by the provisions of 27 this Chapter, any rule or regulation adopted by the Commission, or any 28 existing or future Bond Order or other financing instrument providing for 29 debt of the City payable from revenues of the utility system managed by the 30 Commission (hereinafter "Financing Documents"). 31 Fails to comply with an attendance policy adopted by the City Council that (2) 32 is applicable to all other City boards and commissions. 33 Is convicted of a felony. (3)34 (4) Is convicted of a misdemeanor involving moral turpitude, misrepresentation, 35 or fraud. 36 "§ 6A.7. Powers and duties of Commission. The powers and duties of the Commission are 37 as provided in this Chapter, including all of the following: 38 In general. - Insofar as management, control, and operation of the electric (1)39 utility plant, waterworks, sewerage, and any other utility the Commission is 40 authorized to undertake under this Chapter, the Commission is a separate 41 and independent public authority within the meaning of G.S. 159-7(b)(10), 42 and the provisions of this Chapter shall be liberally construed to accomplish 43 this intent and purpose. Except as expressly provided in this Chapter and in 44 any Financing Documents, the Commission shall be free from the 45 jurisdiction, direction, or control of City officers and employees and of the 46 City Council. 47 (2) Policy matters. - The Commission shall have full charge and control over 48 policy matters related to and the general supervision and management of all 49 utilities under its management and control. 49 50	revenue bonds or notes, as shown by the budget ordinance, but shall set

14	"§ 6A.17. Audit of books; access to financial records. At the end of each fiscal year, the
15	books, accounts, and records of the Commission shall be audited by a certified public
16	accountant or an accountant certified by the Local Government Commission as provided in
17	G.S. 159-34. The City Council shall select the auditor, and the auditor shall report directly to
18	the City Council. Upon giving reasonable notice, the City Council shall have full access to the
19	books, accounts, and records of the Commission.
20	"§ 6A.18. Quarterly and annual reports. (a) The Commission shall, on a quarterly basis,
21	provide to the City Council a report on its activities and the utilities under its management and
22	control. The City Council shall collaborate with the Commission to determine the form and
23	content of the quarterly report.
24	(b) The Commission shall, at the end of each fiscal year, publish in the manner
25	provided for in G.S. 159-12 a complete report that includes all financial operations of the
26	Commission during the year and any other items, facts, and information determined by the City
27	Council to be in the public interest. The City Council shall collaborate with the Commission to
28	determine the form and content of the annual report.
29	"§ 6A.19. Revenue bonds. The City Council shall have the sole authority to issue revenue
30	bonds pursuant to the provisions of Article 5 of Subchapter IV of Chapter 159 of the General
31	Statutes for the purpose of providing funds for the construction, repairing, alteration,
32	enlargement, extension, or acquisition of any utility, building, or other property under the
33	Commission's management and control. However, if the revenue bonds are to be payable in
34	whole or in part from the revenues of a utility under the management and control of the
35	Commission, the City Council and Commission shall, by majority vote of each entity, prior to
36	the issuance of the revenue bonds, agree on the capital costs of the project and the amount of
37	the bonds. The term "capital costs" is as defined in G.S. 159-48(h). In addition, the City
38	Council must approve by majority vote the incurring of debt or other financing of the utilities
39	that involves the pledging or securing of the revenues, utilities, plant, property, or equipment to
40	which it holds title pursuant to Section 6A.9 of this Chapter. The proceeds from the sale of any
41	revenue bonds or from the issuance of other debt referenced in the preceding sentence shall be
42 43	paid over to the treasurer of the Commission as agent for the City, who shall disburse the same as provided in this Chapter and shall be applied in the manner set forth in the Financing
43 44	Documents.
44	"§ 6A.20. Contracts. All contracts, purchases, leases, or agreements made by or on behalf of
46	the Commission shall be in accordance with the laws of the State of North Carolina. Any
40 47	contract undertaken by the Commission that requires the estimated expenditure of funds in the
48	amounts provided for in G.S. 143-129 shall be approved by at least three members of the
49	Commission. The Commission may enter into binding contracts and agreements with the City.
50	The Commission may financially support local initiatives, such as economic development,

1 which may enhance or support the provision and growth of utility services if approved by at 2 least three members of the Commission. 3 "§ 6A.21. Shared or centralized services. The Commission shall pay for services received 4 from the City, and the City shall pay for any services received from the Commission, and the 5 payments shall be accounted for as provided by this Chapter, general law, or guidelines 6 established by the Local Government Commission. The services shall only be provided by the 7 City or Commission if they can be performed at or below prevailing market rates. If the 8 services cannot be provided at or below prevailing market rates, the City or Commission shall 9 provide its own services or contract with a third party to provide the services. 10 "§ 6A.22. Special assessments. The City Council may impose a special assessment for any 11 purpose related to the provision of utility services against benefitted property as provided in 12 Article 10 of Chapter 160A of the General Statutes. \$ 6A.23. Retirement System. The Commission may participate in the North Carolina Local 13 14 Governmental Employees' Retirement System. 15 "§ 6A.24. Investment authority. In addition to the authority granted in G.S. 159-30, the 16 Commission may invest and reinvest any of the Commission's employee benefit funds held in 17 trust, risk reserve funds, and capital reserves, as designated from time to time by the 18 Commission, in one or more of the types of securities or other investments authorized by State 19 law for the State Treasurer in G.S. 147-69.2(b)(1) through (6) and (8)." 20 **SECTION 3.** Notwithstanding the provisions of Section 1 of this act, the current 21 members of the Public Works Commission of the City of Fayetteville, being Lynne Greene, 22 Michael G. Lallier, Darsweil Rogers, and Wade R. Fowler, Jr., may continue to serve on the 23 Commission until their successors are appointed in September of 2015, 2016, 2017, and 2018, 24 respectively. 25 SECTION 4. The procedures of the Charter do not purport to contain all acts 26 necessary to carry the power, duty, function, privilege, or immunity into execution, and 27 therefore the Charter procedure shall be supplemented by the general law procedure; but in case 28 of conflict or inconsistency between the two procedures, the Charter procedures shall control, 29 pursuant to G.S. 160A-3(b). 30 **SECTION 5.** Nothing herein is intended to contravene any provision of any 31 Financing Documents, and therefore, to the extent required for compliance with the express 32 provisions of such Financing Documents: 33 The actions of the Commission authorized pursuant to the terms of this new (1)34 Chapter VIA of the Charter of the City of Fayetteville shall be deemed to be 35 caused by actions of the City: 36 (2) No provisions of these amendments to the Charter shall be interpreted or 37 applied to change the ownership or status of any revenues, plant, property, or 38 equipment pledged as security for any outstanding indebtedness, and any 39 such revenues, plant, property, and equipment shall remain so pledged; 40 The budget process, the handling of records and accounts, receipts and (3) 41 disbursements, maintenance of cash reserves, remittances of funds to the 42 City, and payment of bond proceeds as set forth in Sections 6A.12 through 43 6A.16 and Section 6A.19 of the Charter amendments shall be subject to the 44 terms of any Financing Documents; and 45 (4)Nothing herein shall be deemed to limit, impair, or alter the rights vested to 46 bondholders or creditors under any Financing Documents. 47 **SECTION 6.** This act becomes effective July 1, 2015.
